Jay Mannio owner of the property where the work has to be done wanted to know what the District was going to do about his exposure to the damage that was done to his property from the pipeline leak. The board offered to fill in wholes with dirt or fence off the area where erroded, until the repair is done. The board asked him what he would like them to do to minimize his exposure. Mannino declined to respond to the boards proposal of solutions to help minimize liability risk while the repair/replacement is being planned and performed, instead preferring that the board make a formal proposal. GID noted that they will work with land owners as mutually agreed to by both parties to have the repair complete prior to April 1, 2024.
